Terms of registration and submission of materials

Submit the participant's abstracts and registration form by October 25, 2022 in electronic Microsoft Word format to the organizing committee's email address kmmt.nau@ukr.net separate files:

- registration form of the conference participant (**Surname and initials_reestration form**)
- theses (Surname and initials_theses)
- subject of the email "Surname and initials_Department_ University"

Theses should contain a small report on scientific research or practical results of the author (s) related to the conference topic.

Theses are submitted in Ukrainian or English. The volume of theses is up to 4 pages in A4 format.

Materials must be original, not previously published and not under consideration for publication at the time of submission to the conference.

Materials are published in the author's editorial office.

The authors are responsible for the accuracy of the presented material

No more than 2 Presentations (theses) can be submitted from one author.

The requirements for the design of abstracts are given below.

Theses will be published in the electronic collection of scientific papers of the conference and posted in the Electronic Library of NAU and on the official website of the Department of computer multimedia technologies based in NAU.

Requirements for thesis design

Structure of the report materials. The report materials should contain a statement of the practical problem, a list of tasks to be solved, a statement of the essence of the study (text, graphs, figures, screenshots, etc.), conclusions, and a list of information sources.

Abstracts are submitted electronically in *Microsoft Word* format with a volume of up to 4 pages A4, portrait orientation, *Times New Roman* 14 pt, 1.5 intervals with width alignment and automatic transfer placement. The paragraph indent is 10 mm. Margins: all page margins are 20 mm.

Order of material placement

The first line is UDC (left alignment).

After skipping a line, print the abstract title in **LARGE BOLD LETTERS** 14 pt., font typeface – Times New Roman, place in the center.

Skipping the line-full name of the authors with an indication of their academic degrees if there are authors from different organizations, marks are made (1, 2) after the author's last name and before the name of the organization. Next line-the names of organizations/institutions are indicated in full, in italics, in the center, Times New Roman 12 pt. The next line – information about the supervisor (if any) is indicated on the right, italic indicate the surname and initials, position, scientific degree.

Omitting the line-abstract in the language of the thesis (Times New Roman, 11 pt., italic), width alignment.

In the next line, the **Keywords** are (Times New Roman, 11 pt., italic), width alignment.

Skipping the line-research materials (Times New Roman, 14 pt.) with a mandatory statement of the problem, a list of tasks to be solved, a statement of the essence of the study and the formulation of conclusions that should correspond to the task at hand.

LIST OF INFORMATION SOURCES is given in the order of references in the text according to DSTU 7.1:2006 "bibliographic record, bibliographic description. General requirements and rules of compilation", and is placed after indenting one free line from the main text in the center of the page in capital letters (**LIST.....**). The font size 11 pt. References to information sources in the text are given in square brackets, for example [1], [2,3] or [1, p. 15].

After the list of information sources, the abstract is placed in English in the following order:

- **1.1** *Title of the article in English.* Performed in accordance with the requirements of Clause 1 and is an authentic translation of the title in the language of publication.
- **1.2** The author's initials and surname are in English. Performed in accordance with the requirements of clause 1.the author's initials and surname are indicated in Latin transliteration, then the names of organizations in English.
- **1.3** The annotation in English begins with the word "Annotation", Times New Roman 11 pt., italic, interval before-6 pt., width alignment.
- **1.4** *Keywords in English.* The list of keywords starts with "*Keywords*:" Times New Roman, 11 *pt.*, *italic*, width alignment.

Notes: For thesis written in Ukrainian, the second abstract is given in English.

Rules for formulas design

Formulas are created as separate objects in the *Microsoft Equation* or *MathType*, centered and numbered within the article. the number in parentheses is pressed against the right side of the sheet. Default editor settings. The formula should be followed by a punctuation mark, and if the formula contains explanations, they should start with a new paragraph with the word "where" without indentation.

Annotation. in the language of thesis Times New Roman, 11 pt, italic.

Keywords: Times New Roman, 11 pt., italic, separated by commas, width alignment.

Thesis should convey the main content of the report and include: a statement of the problem in a general form and justification of its relevance; the formulation of novelty and scientific achievements of the author; the formulation of the main research task; a summary of the solution of the task; conclusions should contain the main results obtained. The authors are responsible for the content and accuracy of the submitted materials.
